PRETRIAL ORDER NO. 195

AND NOW, this 15th day of April 2013, upon consideration of the application for fees and costs incurred by Special Master Patrick Juneau for fees and expenses incurred from January 1, 2013 through March 31, 2013, totaling \$4938.58, and finding that the work, fees and costs reflected thereon are “reasonably necessary” for the fulfillment of the Special Masters’ duties, and without objection from counsel, it is hereby **ORDERED** that the application for fees and costs is **APPROVED** in full. Accordingly, the parties are responsible for payment of an equal half share of the same, and should make payment forthwith.

It is further **ORDERED** that the Administrator of the Avandia Litigation Common Benefit Fund, Andrew A. Chirls, is authorized to withdraw from the Common Benefit Fund the amount of \$ 2,469.29, constituting the Plaintiffs’ Advisory Committee portion of the fees and expenses still outstanding, and pay said amount forthwith to Special Master Patrick Juneau, in satisfaction of the portion of the fees and expenses incurred for Plaintiffs’ common benefit through March 31, 2013.

It is so **ORDERED**.
