**JOINT STIPULATION TO EXTEND THE FEBRUARY 15, 2014
DEADLINE FOR MOTIONS RELATING TO THE INITIAL
EXCHANGE OF DOCUMENTS TO MARCH 28, 2014**

Direct Purchaser Plaintiffs and Indirect Purchaser Plaintiffs (collectively, "Plaintiffs"), after consultation with and consent from Defendants CertainTeed Corporation, USG Corporation and United States Gypsum Company, New NGC, Inc., Lafarge North America Inc., American Gypsum Company LLC, TIN Inc., and PABCO Building Products, LLC (collectively, "Defendants"), submit the following stipulation to extend the February 15, 2014 deadline for any motions relating to the initial exchange of documents (Dkt. 76, ¶ 6) to March 28, 2014.

WHEREAS, Defendants have collectively produced over 2,000,000 pages¹ of documents;

WHEREAS, the vast majority of that production was made on or about January 15, 2014, consistent with the deadline for Defendants to substantially complete production (Dkt. 76, ¶ 1);

WHEREAS, on or about January 15, 2014, six out of seven Defendants advised Plaintiffs that supplemental productions would be forthcoming, including transactional data, to complete their Phase One production;

¹ Please note that the page count does not fully reflect the size of Defendants' productions given that Defendants have produced a substantial number of native files. Native files are only counted as one page despite the fact that they may be large spreadsheets or lengthy presentations.

WHEREAS, all Defendants who have not already completed their production have advised that they intend to make their supplemental productions on or about February 15, 2014;

WHEREAS, Plaintiffs have been diligently working to assess the completeness of Defendants' productions, although this process has been complicated by the size of the productions;

WHEREAS, Plaintiffs and Defendants anticipate reaching out to each other shortly to discuss the initial issues they have identified regarding their initial productions;

WHEREAS, the parties are hopeful that most, if not all, issues identified concerning their productions can be resolved through the meet and confer process without intervention by the Court;

NOW THEREFORE, Plaintiffs and Defendants have agreed, subject to Court approval, that the February 15, 2014 deadline for motions relating to the initial exchange of documents (Dkt. 76, ¶ 6) should be extended to March 28, 2014. The March 28, 2014 deadline should apply to motions by either Plaintiffs or Defendants, and all other deadlines in the case shall remain unchanged.


