**PRETRIAL ORDER NO. 84  
(CHANGES TO THE INDIRECT RESELLER  
PLAINTIFFS' STEERING COMMITTEE)**

**AND NOW**, this 8th day of April 2019, upon consideration of the Indirect Reseller Plaintiffs' Steering Committee's Unopposed Motion for Substitution of Counsel [Doc. No. 928], and after a General Status Conference held on April 5, 2019, it is hereby **ORDERED** that the Motion is **GRANTED** and Pretrial Order No. 21 is **AMENDED** as follows:

1. Elizabeth Tipping has left the law firm of Neal & Harwell, PLC, and at her request, Ms. Tipping is relieved from her position on the Indirect Reseller Plaintiffs' Steering Committee. In her place, the Court appoints:

to the Indirect Reseller Plaintiffs' Steering Committee to perform the duties set forth in Pretrial Order No. 1. This new appointment is of Ms. Samson; the appointment continues as to the law firm.

2. At their request, Daniel S. Mason and the law firm of Furth Salem Mason & Li, LLP and Francis O. Scarpulla and the law firm of Francis O. Scarpulla, are relieved from their positions as members of the Indirect Reseller Plaintiffs' Steering Committee.

3. The Court invites the submission, no later than **April 26, 2019**, of individual applications for positions of membership or leadership of the Indirect Reseller Plaintiffs' Steering Committee. The applications must be filed in MDL 2724. The main criteria considered will be willingness and availability to commit to a time-consuming project, ability to work cooperatively with others, and professional experience in this type of litigation. Applications should succinctly address each of the above criteria and any other relevant matters. No submissions longer than three pages will be considered. Only attorneys of record in this litigation may apply. Any objections to the appointment of any applicant must be in writing, and must be filed no later than **May 3, 2019**. Objections must be succinct, and must be supported by necessary documentation. Finally, no later than **May 10, 2019**, applicants may file a reply to any such objection lodged against them.
