Since early December, 2014, the Northern District of Ohio has received Orders of Remand for hundreds of maritime asbestos litigation cases that had been proceeding in the Eastern District of Pennsylvania before Judge Eduardo Robreno in the MDL 875 Asbestos Litigation. Thus far, 850 cases have been remanded with about 2,600 remands being anticipated overall.

Judge Robreno has advised this Court that the remanded cases are ready for trial. Judge Robreno has also advised that several parties have indicated that settlements may be achieved in some of these cases with the assistance of this Court.

While this Court has a long-standing tradition of maintaining the asbestos cases on the docket of the Chief Judge until those matters become trial ready, all the district judges across the Northern District of Ohio stand ready to be assigned and conduct any trials that may be necessary.

Settlement Conference for Selected Parties - Monday, March 16 at 9:00 a.m.

As an initial step in addressing these remands, I have asked Judges Dan Aaron Polster and David A. Katz to jointly conduct a conference to finalize settlements in the group of cases listed in Appendix A in which one or more of the following defendants are the sole defendants in the case:

A.W. Chesterton Co.,
Gatke Corporation,
General Refractories
IMO Industries
John Crane Inc.
John Crane-Houdaille, Inc.

The conference is set for Monday, March 16 at 9:00 a.m. in Judge Polster's Courtroom (18B) in the Carl B. Stokes Court House in Cleveland. Lead counsel and representatives of defendants with settlement authority are required to attend.

Counsel for plaintiffs and defendants should consult well in advance of the conference and work together to file any dismissal entries or executed settlement agreements that can be achieved prior to the March 16th conference by the close of business on Monday, March 9th.

Electronic Filing

All documents filed with this Court in this litigation should be filed electronically in the Court's CM/ECF Asbestos system. As you may be aware, the electronic filing system now in use throughout the federal judiciary was first pioneered in 1996 in the Northern District of Ohio for this maritime asbestos litigation. The overwhelming majority of the dockets related to the maritime asbestos litigation cases already reside in the original CM/ECF Asbestos system, which is separate from, but which has been updated to provide the same functionality as, the district's Live CM/ECF system used for the Courts traditional civil and criminal cases. The Clerk's Office will enter the dockets of any of the other remanded cases into the CM/ECF Asbestos system soon.

All attorneys expecting to file or be noticed of filings in this litigation are required to obtain an account (identification name and password) for the CM/ECF Asbestos system which can be accessed through the Court's web site or at:



Please note that the Clerk's Office is currently working to reopen and update the dockets on these cases, which may take some additional time. The Clerk's Office may also need to rebuild a small number of cases from other systems. If you are unable to access a particular case within the CM/ECF Asbestos system please contact the Clerk's Office help desk at the number above.

Filings should be made in individual cases whenever possible. Filings that relate to all cases, or to all the cases of a particular defendant, may be made to Master Docket Case No. 10-1 if it is impractical to do otherwise. Call the Clerk's Office for assistance if you are unsure of how to proceed.
