STATUS AND SCHEDULING CONFERENCE

**AND NOW**, this **4th** day of **January 2009**, it is hereby

**ORDERED** that:

1. Each case on the attached list shall be reactivated from the civil suspense file by the Clerk of the Court for further disposition by the Court. The Clerk of the Court shall assign each case an Eastern District of Pennsylvania case number.

2. A status and scheduling conference will be held in the captioned cases<sup>1</sup> on **Thursday, February 25th, 2010** at **10:00 am** in Courtroom 11A, United States Courthouse, 601 Market Street, Philadelphia, PA 19106. Prior to the conference, counsel for all parties shall review and ascertain the status of their client(s) in each case.

3. Prior to entering an appearance in any action, counsel shall register for CM/ECF filing with the Clerk of the Court for the Eastern District of Pennsylvania. All official filings submitted in any of these actions must be filed electronically under the new E.D. Pa. case number by a registered attorney. All orders, opinions, and other docket entries generated from chambers will likewise be filed directly on to ECF.

4. On or before **Thursday, January 28th, 2010**, Plaintiffs' counsel shall file a notice with the Court which identifies each Defendant remaining in each case and the contact information including address and telephone number for that remaining Defendant's counsel.

5. The Court will enter an order dismissing without prejudice all viable defendants not identified in each case by plaintiffs' counsel. Cases with no remaining viable defendants will be dismissed without prejudice or transferred to the bankruptcy only docket.

6. On or before **Thursday, February 3rd, 2010**, counsel for each remaining Defendant shall enter their appearance and a general denial of all the allegations contained in the complaint.

7. On or before **Thursday, February 10, 2009**, plaintiff's counsel shall serve upon each remaining Defendant in each case the medical diagnosing report or opinion upon which that Plaintiff relies in pursuing their claim.

8. At the hearing, a briefing schedule for any

appropriate procedural or preliminary substantive motions will be discussed.
