O R D E R

AND NOW, this 20th day of **August, 2014**, it is hereby **ORDERED** that a final pre-remand conference in the cases listed in Exhibit "A," attached, will be held on **Tuesday, September 23, 2014** at **2:00 p.m. in Courtroom 15A**, James A. Byrne United States Courthouses, 601 Market Street, Philadelphia, Pennsylvania 19106.

It is further **ORDERED** that all listed plaintiffs and all parties listed as a "pending defendant" in the associated cases in Exhibit "A" must attend the final pre-remand conference and must be prepared to provide and/or discuss the following:

- 1) The civil action number of the case in the district where it was originally filed;
- 2) The civil action number of the case in the Eastern District of Pennsylvania;
- 3) The name of the plaintiff in the case;
- 4) The diagnosing report or opinion relied upon by plaintiff in compliance with Administrative Order

No. 25;

- 5) The identity of defendants that are still viable in the case¹;
- 6) A certification that counsel for all remaining parties are aware that the case may be remanded;
- 7) The specific reasons why remand is appropriate in the case, including, but not limited to:
 - a) Whether the parties have complied with Administrative Order No. 25;
 - b) Whether the injured plaintiff is alive;
 - c) Whether the parties have submitted a Rule 26(f) report to the Court;
 - d) Whether all relevant discovery has been completed or has been substantially completed. If not, identify the discovery still to be completed.
 - e) The extent to which settlement conferences have been held in the case and the status of settlement negotiations.
 - f) Whether there are any outstanding motions in the case. Counsel seeking remand should be able to certify that there are no outstanding motions remaining in the case.

¹ A viable defendant is a defendant which has not been dismissed from the case and is not in bankruptcy proceedings.

- g) Whether, if the case is remanded, the parties are prepared for trial without delay once on the transferor court's normal docket.
- h) The status of congestion in the transferor court's docket.

Failure to appear at the final pre-remand conference may result in the imposition of sanctions pursuant to Rule 11.
