O R D E R

AND NOW, this **17th** day of **September, 2010**, it is hereby **ORDERED** that hearings on all pending motions for summary judgment in the cases listed in exhibit "A", attached, will be held on **Thursday, October 21st, 2010** at **10:00 a.m.** in Courtroom 11A, James A. Byrne United States Courthouse, 601 Market Street, Philadelphia, Pennsylvania 19106.¹

It is further **ORDERED** that this conference constitutes the final pre-remand conference in each of these cases. If there are viable defendants remaining in any case, counsel should inform the Court at the conference, or via letter prior to the conference, as to the status of the case. If the case has

Additionally, the parties should notify the court of any case with an amended scheduling order for which the time for summary judgment motions has not yet passed.

satisfied the factors listed in MDL-875 Administrative Order no. 18, the Court will suggest that the case is remanded to the transferor district court.

It is further **ORDERED** that if the remaining viable defendants in any of these cases are settled or dismissed, Plaintiff shall inform the Court of these settlements or dismissals and provide proposed orders for the Court to review. Plaintiff shall also inform the Court if they wish to dismiss the entire case as to any remaining viable defendants, and whether or not the case should be moved to the "bankruptcy-only" docket.²

It is further **ORDERED** that any previously scheduled status conferences in these cases are **RESCHEDULED** for Thursday, October 21st at 10:00am.
