

# THE HONORABLE EDMUND V. LUDWIG



In 1928, the Honorable Edmund V. Ludwig was born in Philadelphia. He passed away on May 17, 2016, just three days shy of his 88<sup>th</sup> birthday. Judge Ludwig graduated from Germantown Friends School and earned degrees from Harvard College and Harvard Law School. A Korean War veteran, he was honorably discharged from the Army Judge Advocate General's Corps in 1956.

Judge Ludwig had resided in Doylestown, Pennsylvania, since beginning in private practice in 1958. In 1968, he was elected to the Bucks County Court of Common Pleas and it was there that his interest in mental health reform began. His colleague and fellow Bucks County resident, U.S. District Judge Cynthia Rufe, recalled appearing before Judge Ludwig when she was a public defender. Judge Rufe noted that Judge Ludwig had a gift for knowing how to steer troubled youth from delinquency to rehabilitation. Judge Ludwig sat on the state court until his appointment to the United States District Court by President Ronald Reagan in June 1985. Judge Ludwig became a senior judge in 1997.

In one of his noteworthy cases, Judge Ludwig presided over the Major League Baseball umpires' strike in 1996. This strike was particularly heated because it began when Roberto Alomar, angry over a third strike call, spit at umpire John Hirschbeck. Alomar claimed Hirschbeck had uttered a racial slur. Judge Ludwig ordered the umpires back to work but calmed the waters by finding: "These umpires are the best, and without them, the harm to baseball will be irreparable. The game of baseball occupies a special place in this country and it belongs to the millions of fans."

Judge Ludwig will always be a favorite son of Doylestown. His love of Doylestown grew as he became involved in the town's history and culture. Judge Ludwig founded the Doylestown Historical Society and served as its chairman until 2011. He collected oral histories of prominent citizens, worked on books about Doylestown's past, and placed historic markers all over town. He made it a priority to preserve its charm.

Judge Ludwig was involved with various social service programs and served on the boards of organizations dealing with juvenile justice, mental health, and rights for women and the disabled. He co-founded TODAY, Inc., a residential treatment drug program, in 1971, and served on its board until 1985. He was also an educator and held positions at Hahnemann University, Temple Law School, Villanova Law School, and the University of Pennsylvania.

He enjoyed tennis, dining out, and spending time with his children, Edmund V., Jr., Toby, Sarah, and David, and his six grandchildren. An avid reader, Judge Ludwig enjoyed Shakespeare, poetry and historical fiction. Always ready with a joke or pun, Judge Ludwig's humor will be missed by his family, friends, and colleagues on the court.
