**ORDER**

**AND NOW**, this 19<sup>th</sup> day of March 2012, it is hereby **ORDERED** that counsel representing one or more Plaintiffs listed on Exhibit A shall provide Plaintiffs' Coordinating Counsel Paul Kiesel with the names any of their Exhibit A clients who are alleging that they suffered from myocardial infarction/ heart attack due to Avandia usage, along with a short summary of each such Plaintiff's case, no later than **March 27, 2012**. Failure to timely provide this information may result in sanctions.

It is further **ORDERED** that, upon receipt of these names and case summaries, Plaintiffs' Coordinating Counsel shall confer with counsel for Defendant regarding the lists of myocardial infarction/ heart attack cases. Plaintiffs' Coordinating Counsel and counsel for Defendant shall then provide the Court with an agreed-upon list of myocardial infarction/ heart attack cases, along with the case summaries, by **March 30, 2012**. It is from this list that the Court will select cases for trial.

It is further **ORDERED** that any attorney who believes that one or more of the listed Plaintiffs' cases should not be placed in a trial pool because the case has been settled, is in

suspense, is subject to remand, or is otherwise listed in error as an active case, shall **SHOW CAUSE** why the case should not be listed for trial. All such submissions must be filed by **March 27, 2012.**

It is so **ORDERED.**
