

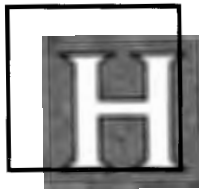
PRETRIAL ORDER NO. 26
