

**Results of the December 13, 2011 status and  
scheduling conference for certain MARDOC cases**

Updated Dec. 15, 2011

A sortable, searchable Excel workbook (consisting of seven (7) worksheets) has been posted on the MDL-875 MARDOC web page (<http://www.paed.uscourts.gov/mdl875m.asp>). The workbook contains a complete list of all of the cases listed for the status and scheduling conference (as the first workbook), as well as six (6) worksheets that list the case numbers that pertain to the following categories. Please refer to the tabs on the bottom of the workbook to find the appropriate list you wish to search or sort.

- 1.) 2,636 cases have been transferred to the bankruptcy-only docket and will be marked CLOSED.
- 2.) 4,038 cases have been voluntarily dismissed / dismissed for lack of prosecution due to plaintiffs' unavailability or decisions not to pursue their claims. These cases will be marked CLOSED.
- 3.) Four cases are represented by counsel other than The Jaques Admiralty Law Firm. Those counsel are expected to enter appearances.
- 4.) Plaintiffs counsel are moving to "reactivate" the case of Richard M. Bradwell, E.D. Pa. civil action no. 11-56823. This motion is subject to Judge Hey's Order of October 19, 2011 (which is available on the MARDOC web page).
- 5.) Fifteen cases are being dismissed for lack of prosecution. These cases will be marked CLOSED.
- 6.) Approximately 73 cases that were listed for the Dec. 13 conference were previously on scheduling orders in MARDOC Groups 1-7.

Additionally, there were some issues regarding duplicate or incorrect case numbers.<sup>1</sup> The Clerk's

<sup>1</sup> Robert N. Cain (Group 1 Oil Companies) and John L. Cain, Jr. (Group 2 West Coast) were both on scheduling orders under the same EDPA#, 11-cv-54528. This EDPA number actually belongs to Robert N. Cain. The EDPA number for Robert N. Cain should have been 11-cv-54367 and has been corrected.

John L. Cain, Jr., 11-cv-54528 was in Group 2 West Coast with the incorrect EDPA number. It should be cause nos., 11-cv-57803 and 11-cv-57804. Both of these cases were set for status and scheduling conference on 12-13-11. These two cases are now consolidated as one action.

Juan C. Lausell, 11-cv-58058 is in Group 4 East Coast 2 and was set for status

and scheduling conference on 12-13-11. Case no. 11-cv-58059 is not on a scheduling order but was also set for conference on 12-13-11. These two cases are now consolidated under 11-cv-58058.

Roman C. Martinez, 11-cv-58075 is in Group 3 East Coast 1 and was set for status and scheduling conference on 12-13-11. Case no. 11-cv-58081 is set for status and scheduling conference on 12-13-11. These two cases are now consolidated under 11-cv-58075.

Tyrone J. Matthews, 11-cv-55331, is in Group 4 East Coast 2 and was set for status and scheduling conference on 12-13-11. Case 11-cv-55332 was set for scheduling conference on 12-13-11. These two cases should be consolidated under 11-cv-55331.

Terry L. Cassidy, 10-cv-30220 is in Group 2 West Coast with the incorrect EDPA number. The correct EDPA # is 11-cv-30220. Case 10-cv-30220 belongs with Rafael C. Matos which was closed on 12-6-10.

Edwin H. Ellison, 11-cv-30461 is in Group 2 West Coast with the incorrect EDPA number. The correct EDPA # is 10-cv-50818. Case no. 11-cv-30461 was closed by Judge Robreno because it was originally assigned two cause numbers by the Court.

Donald L. Ware, 2:11-cv-40797 is in Group 2 West Coast. This case is consolidated with 11-cv-40798.

Terry W. Fager, 9-cv-30165 is in Group 3 East Coast 1 with the incorrect EDPA number. The correct EDPA number is 10-cv-37613. These two cases were previously consolidated by Judge Robreno.

Leonard T. Bielicki, 10-cv-37834 is in Group 5 with the incorrect EDPA number. It should be 11-cv-33270. These two cases were consolidated previously by Judge Robreno.

Cecil Harris 11-cv-49379 is on a Scheduling Order, Group 6 Towing. It should be consolidated with 11-cv-49378.
