**ORDERED** that the motion is **GRANTED**, as follows:

- 1) The defendants shall file any supplemental expert report(s) related to the new information outlined in their motion by **Friday**, **January 29**, **2016**.<sup>1</sup>
- 2) The plaintiff shall file a response, or responses, to the defendants' supplemental expert report(s) by **Friday**, **March 18**, **2016**.
- The defendants may file any additional <u>Daubert</u> motion(s) based on a supplemental expert report, or reports, by Friday, January 29, 2016.
- 4) The plaintiff shall respond to any additional <u>Daubert</u> motion(s) filed by the defendants based on the supplemental expert report(s) by Friday, March 18, 2016.<sup>2</sup>
- The plaintiff may file any additional <u>Daubert</u> motion(s) based on the supplemental expert report(s) by Friday, March 18, 2016.
- The defendants shall respond to any additional <u>Daubert</u> motions filed by the plaintiff by Friday, April 8, 2016.
