ORDER

AND NOW, this 28th day of September, 2012, in light of the significant number of motions to extend expert discovery deadlines recently filed by all parties and the fact that the extensions sought have often passed by the time the opposing party has responded to the motion, and after a September 27, 2012 hearing on the issue, it is hereby **ORDERED** that:

- (1) before filing a motion to extend an expert discovery deadline, the parties shall make a good faith attempt to work out an agreement between themselves;
- (2) if a motion for extension is necessary, within 24 hours of being filed, the opposing party shall email Joel Lang and state whether that party will file a response to the motion; and
- (3) if the opposing party opts to file a response, it must be filed within three days after the motion is filed.
